Director's Report to the Sun Region

My first National Board meeting session in Louisville was quite the experience. It was probably the most intense set of meetings I've ever attended. Mixed with the air of the "all for the greater good" attitude were some very interesting problems, solutions, new concepts for the direction that EGA might head like new ideas for on-line classes, social media and the likes. There are some very talented and interesting RD's and executive officers on the current board.

I was fortunate to meet our National office staff. Our new Administrator, Sharon Chatman, is a real asset. She's a dynamo and I think EGA will definitely benefit from having her on staff. She has a background in non-profits, fundraising and management. Everyone in Louisville has done a great job of settling into the new office space and setting up a beautiful gallery display.

Here are the key take-aways:

A. National Seminar Committee:

A National Seminar Committee has been created under the VPO (no longer operations, just VP), to only work seminars. There are 3 positions: National Seminar Director, who will chair and run all seminars; National Seminar Treasurer who will deal with all financial aspects of the seminar; and, a National Seminar Registrar who will establish the means of registration and tends to all registration functions. These positions initially will be a 2 year appointment evolving into a 3 year term that encompasses a year of training and transition. The host region will have assistants for chair, treasurer, dean of faculty, and registrar. The financial split would change to 60 (EGA) / 40 (Region).

- B. Education Changes:
 - 1. On-Line Classes and social media development:

Sue Hacker Nelson, the National Marketing Chair, is researching the mechanics of how EGA would offer on-line classes. These classes could be workshops, GCCs, or possibly classes from seminars. She is also looking into publishing How-To videos on YouTube.

2. Videos and Slides:

These media will be converted to DVD and CD where appropriate and may be a downloaded file from the National website under the Education tab.

C. Redesign of the National Web Site

Work is underway to revamp the EGA website which will result in greater capability for members by facilitating on-line classes and possibly web casts. This goes hand in hand with the push for more on-line education content. The BIG unveiling will be at the Santa Fe National Seminar. We saw a short demo which was very nice.

- D. Budget Discussion:
 - 1) EGA membership numbers have increased slightly over last year. Several expense categories have been cut or eliminated in an attempt to streamline our budget. We saw an income increase

in the Education (GCCs, ICCs, Master Craftsman) programs which is very encouraging. We saw a nice profit in the seminar category.

- 2) We may see a \$3 dues increase in 2013. It has been approved but may not be put into effect if the budget situation has improved.
- E. National Tapestry stops traveling in June 2013.
 It was decided that the National Tapestry will need to stop making the rounds outside the EGA headquarters. Its last showing will be in 2013. No new requests for the Tapestry are being granted.
- F. Coming really soon!! New EGA logo merchandise. Four new items are in the works.
- G. Historical documents scanned into a document vault:
- Minutes from 1960 forward and historical EGA documents have been scanned into a document vault.
- H. A Call to update email addresses was made by Sue Hacker Nelson to ensure the EGA National emails and *Inside EGA* email broadcasts were being received by the widest audience possible. Members who are not receiving the broadcasts may contact Tonya Parks at the National office directly to update or add their email address. This is an Opt-In service being provided to our members.
- I. 2015 International Embroidery Conference: Margaret Kinsey will chair this conference


